

**Gartšík Insolvence v.o.s.**, Company ID 21059799, with its registered office at Divadelní 616/4, Brno, insolvency administrator appointed in insolvency proceedings conducted on the assets of the debtor Claire's Czech Republic s.r.o., Company ID 24710156, with its registered office at Antala Staška 2027/79, Prague 4, registered with the Municipal Court in Prague, under file no. No.: MSPH 76 INS 16718/2025 („Contracting Authority “), hereby announces, based on the court's consent granted on 9.3.2026

**Tender for the sale of assets m1: company goods - costume jewelry and fashion accessories, and m2: store equipment, in particular cash registers, cash register and payment system (hereinafter also "assets")**

The listed assets are stored in the premises of shopping centers in Prague, Brno and Pilsen, where the debtor had its establishments. **For details, see Appendix 1 - inventory of assets and 2 - detailed inventory including storage locations**

**The conditions of the tender are as follows:**

a) Only those who are legally qualified may be interested. More detailed requirements for interested parties are set out in a sworn statement **that the interested party is obliged to submit to the contracting authority, signed together with the offer for purchase, and the interested party is obliged to meet all the requirements set out in this statement and at the same time submit to the contracting authority any documentation required by this statement.**

b) If the interested party is interested in submitting an offer for the purchase of property in this tender, the interested party is obliged to submit to the contracting authority a price offer for the entire set of items m1 and m2. The condition is the purchase of the entire set of items of property m1 and m2. An inspection is recommended, the seller does not take into account any later complaints. **The interested party is obliged to send the contracting authority a written offer by e-mail to [insolvence@akggs.cz](mailto:insolvence@akggs.cz) The deadline for submitting offers for the purchase of the offered material is 25.6. 2026 at 12:00 a.m. CEST. No additional conditions and agreements are allowed.**

c) **AML: Within the same period as the written offer, the interested party (not another person) is obliged to send a verification payment from a bank with its registered office in the EU as follows:**

**The verification payment is non-refundable.**

d) **The bid price will be decisive for the selection of the interested party as the winner of the tender; VAT will be added to the bid price in accordance with applicable legal regulations. The bid price must be calculated only in CZK. The purchase price including VAT must be paid before signing the purchase contract. The lowest permissible bid price is CZK 900,000 (excluding VAT).**

e) **Any secondary conditions of the interested party shall result in the rejection of the offer. Secondary conditions are in particular:**

- **Later deviation from the offered purchase price,**
- **Request for a change in the offered purchase price due to the movement of the exchange rate of any currency,**
- **Request for a deviation from the wording of the purchase contract. The interested party must conclude the Purchase Contract in the wording attached to the conditions of the tender procedure,**
- **Failure to send the verification payment**
- **Request for the signing of other documents by the contracting authority other than the purchase contract (orders, transport orders, bank orders, order forms, etc.),**
- **Change of the entity participating in the competition (the purchase contract must be concluded by the entity that submitted the offer, substitution or assignment is not possible)**

**- Requirements for packaging or palletizing of goods or their other preparation or a request for customs declaration or other services from the contracting authority. All costs associated with loading, transport and clearing of the units are borne by the interested party (the contracting authority only “opens the warehouse doors”),**

**- Other conditions that will cause unnecessary extension of the contract; the extent of unnecessary extension of the contract is assessed by the contracting authority.**

f) The interested party must purchase the entire set of property items m1 and m2. The seller does not guarantee the actual quantity of individual items. The interested party waives its rights from defective performance in accordance with the provision of 1916 paragraph 2 of the Civil Code,

g) The items will be delivered to the interested party at individual storage locations (in warehouses in individual centers) according to INCOTERMS 2020 EX WORKS (without any additional packaging or preparation of the goods by the supplier),

h) After the deadline for submitting tender offers has expired, the contracting authority informs the winner of the results of the tender.

i) The contracting authority reserves the right to negotiate the final text of the purchase contract after selecting the most advantageous offer,

j) The contracting authority is also entitled to cancel or amend the tender at any time, without giving a reason and without the interested party being entitled to any claims or any reimbursement of costs for participation in this tender,

k) The contracting authority reserves the right to announce another round of the tender if it concludes that there are reasons that justify re-announcing the tender.

l) The offer must contain:

**- identification data of the interested party (name / first name and surname, ID and registered office / permanent residence);**

**- contact data of the interested party;**

**- the offered purchase price for the entire m1 set and m2 set**

**- information on whether the interested party is a payer of value added tax; if the interested party is established in the EU, he must submit a document on the tax identification number verifiable in the VIES VAT number validation system along with the offer,**

**- a sworn declaration signed by the interested party, the template of which the interested party may not deviate from, except for the addition of his identification and contact data, is an annex to these tender conditions.**

**FAILURE TO FULFILL THE CONDITIONS OF THE TENDER, IN PARTICULAR FAILURE TO ACHIEVE THE MINIMUM BID PRICE, FAILURE TO PROVIDE THE REQUIRED DOCUMENTS OR REQUIREMENTS FOR ANY FURTHER ARRANGEMENTS OR DISCOUNTS WILL RESULT IN THE REJECTION OF THE BID.**
